## Our Town

At a special meeting in the Town Hall at 7 p.m. Monday, June 15, the City Council will conduct a public hearing for residents' comments or questions about the proposed budget for fiscal year 1987-88 including use of mineral-severance tax funds from the State.

The annual budget ordinance is expected to be enacted at the close of that meeting.

Then, at the next regular meeting, at 7 p.m. on Monday, July 6, the Council will have a public hearing on use of State municipal road-aid money.

Written or oral comments or questions may be submitted. Anyone who wishes to do this but cannot attend the public hearings should phone Mayor Vivien H. Reinhardt—241-4243—so that arrangements can be made to obtain the statement.

A copy of the proposed budget is posted on the Town Hall door.

City Council has voted to post a 25-mph speed limit on Elm Avenue between Tulip and Ash Avenues.

The Pewee Valley city tax rate will remain at 23 cents per \$100 valuation for the 1987-88 fiscal year. The City Council passed an Ordinance to that effect on June 1.

Tax bills are scheduled to go into the mail the first part of July. Penalties and interest begin after Aug. 31.

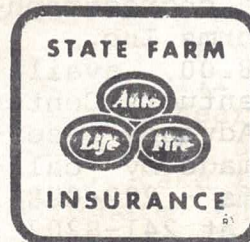

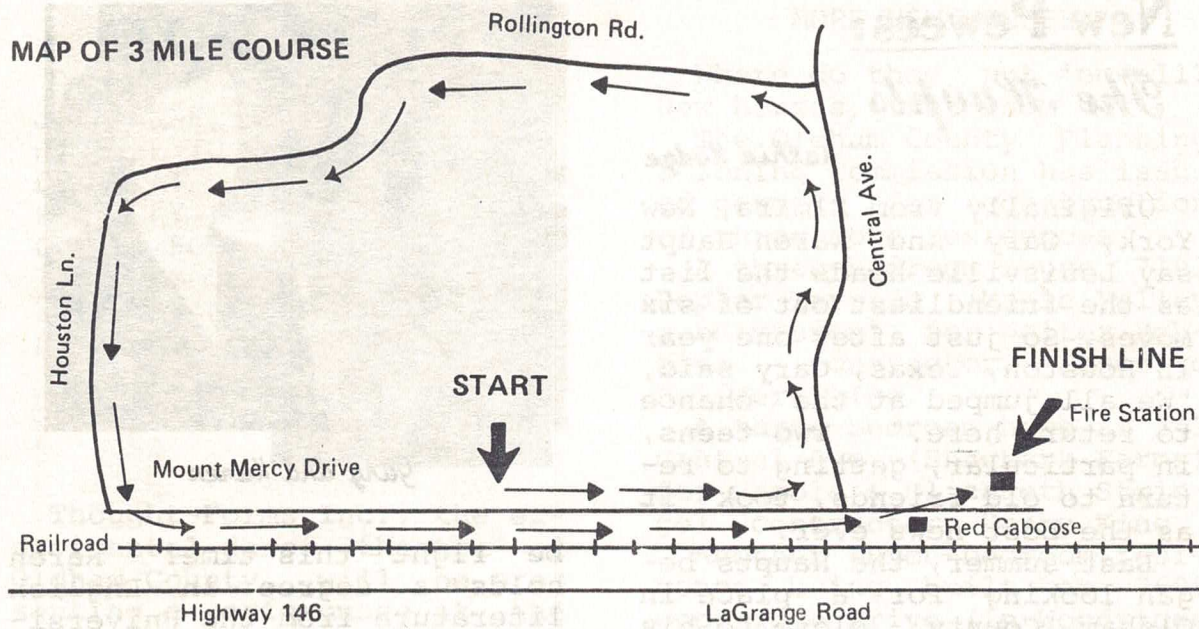

Entry fees are \$10 with all participants receiving a T-shirt. 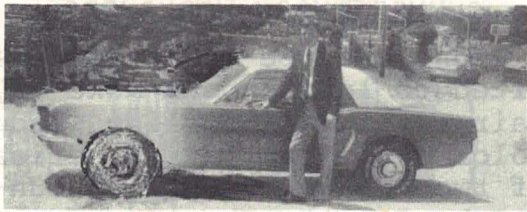

### BANK WITHDRAWAL

Well, two bank robberies in all these years. Could have been a lot worse.

The bandit escaped by the skin of his teeth May 27 with an undetermined amount of money from the Pewee Valley branch of Citizens Fidelity Bank & Trust Co. Oldham County.

Pewee Valley Police Chief Larry Walls was nearby when he got the call, and made his appearance about 30 seconds after the robber completed his quickly-executed heist.

The investigation is now in the hands of the FBI.

It was in the 1950s that Pewee Valley's only other bank robbery occurred. Citizens Fidelity's predecessor, the Bank of Oldham County, was located in its original quarters at the time. Today, the building is occupied by the Pewee Valley Woman's Club.
