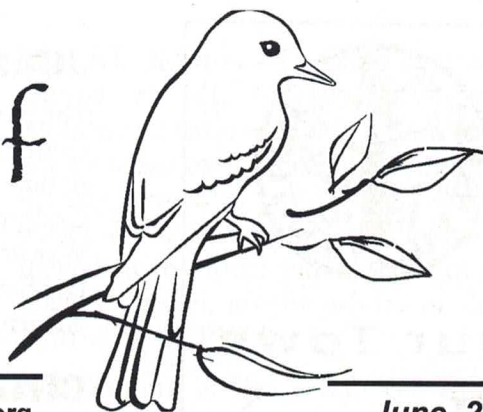

## JUNE COUNCIL MEETING

The sixth regular meeting of the Pewee Valley City Council was held on Monday, June 6, 2005. In attendance were Steve Rowland, Bob Rogers, and Beach Craigmyle, Dick Filippini and Michael Logsdon; Suzy Walser was absent. Also in attendance were City Clerk Debbie Handlson, Mayor Clayton Stoess, Jr., and City Attorney John Singler.

## CITIZEN CONCERNS

Ann Weingardt was concerned about Pewee Valley's lighting ordinance that was to have a second reading at this meeting. A light shines on the parking lot at her dance studio on Hwy. 146 and she was concerned that the ordinance might ban it. She has evening classes and worries about students coming out into a dark parking lot.

Bob Bell voiced concern about the number of trains going through town. There seems to be an increase of trains and more blowing of the horns.

## ANNOUNCEMENTS

**Framing Corporation** - (house on Hwy 146 operating as a business) will have a hearing on its application for re-zoning at the Planning and Zoning Committee on June 28. It will be first on the docket at 9:00 a.m.

**Police** - There have been several applications for consideration for the police position.

**David Osbourne** - Congratulations to David Osbourne for his win in the recent special state representative election.

## COUNCIL MEMBER REPORTS

**Dick Filippini** - Mr. Filippini moved to accept Industrial Disposal's contract for the next year with a 3.7% increase. That increase was taken into account in the new budget. The contract was accepted unanimously.

Mr. Filippini reported that he has contacted CSX regarding the rough railroad crossings. CSX says repairs will begin in July; the company is in the process of picking up the extra ties that have been lying beside the tracks for some time. On motion of Mr. Filippini, the Council approved payment for removal of stumps and iron posts that were guide wire anchors on CSX right-of-way to facilitate mowing, not to exceed \$33 per stump and \$15 per post. This undertaking is subject to approval from CSX.

**Sidewalks** -The survey that was printed in *The Call of the Pewee* indicated a strong public interest in having Peace Lane to Muir Lane be the next phase of sidewalks done. There is a clear right-of-way from Peace to Wooldridge that could be used as a walking path with perhaps wood chips. Kentucky Paving will be giving a price on sidewalks on Ash to Elm Street. There is no right-of-way on Maple, and road plans need to be studied before looking into putting sidewalks on Rollington.

**Michael Logsdon** - The stop sign is to be moved at Mt. Mercy, Houston and Woodridge intersection. LG&E has still not switched over the lights to the city that the city agreed to pay for in January. The notice for a new police officer has been placed in the local paper and not in the *Courier Journal*, on the advice of Captain Griffin at OCPD.

**Bob Rogers** - The Hwy. 146 drainage project has been completed. The repaving work on Maple, Red Plum and Wooldridge will start in the next 30 days. There was a water main break that tied up traffic on Hwy. 146 on Friday and Saturday last week.

## OLD BUSINESS

**Lighting Ordinance** - A second reading was had for the Pewee Valley lighting ordinance. This ordinance will address complaints from citizens regarding glare and lights that infringe on neighboring properties. There will be no "lighting cops"

looking for violations. Existing lighting will be grandfathered in as meeting ordinance requirements, but all lighting must be in compliance with ordinance requirements within 10 years. Oldham County is passing a lighting ordinance. The Council passed the ordinance unanimously on a roll-call vote.

## NEW BUSINESS

**First Reading of the 2005-2006 Budget -**  
A copy of the proposed budget was distributed to all Council members. There was a reserve of \$434,000 in the 2004-2005 budget, but there will actually be about \$491,300 in reserves at the end of the current fiscal year.

**Reimbursement -** Ms. Judy Flowers hit a pothole on Houston that damaged two tires on her car and asked that the City reimburse her for the tires. Motion was made by Mr. Filippini to reimburse her, but the motion failed 4-1.

**CSX Lease -**Payment is due CSX for lease of the land on which the City's message board is located. The amount is \$10 a year, paid in advance for 5 years. The Council unanimously approved payment.

- Mr. Filippini requested that the regularly scheduled July Council meeting be changed from the 4<sup>th</sup> to the 7<sup>th</sup>. The Council approved the rescheduling unanimously.

**Telecommunications Tax** - The first reading of the ordinance regarding the Telecommunications Tax was given by summary by Mr. Singler. A motion to suspend the second reading was made by Mr. Filippini and unanimously approved by the Council. The ordinance was passed on a roll call vote.

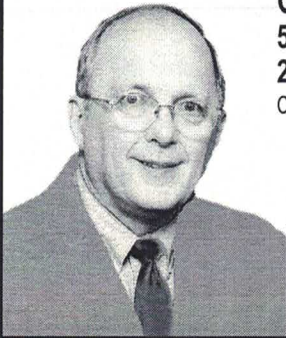
